Providing other health details would be englighteing the readers about whom to perform aneurysmectomy.	
	2) There is a need for explanation of what kind of aneurysmectomy procedure has been performed in a detailed manner. So that the readers can gain more insight about the reason for the success of the aneurysmectomyin this case.	
	3) The study apparently links the LV aneurysmectomy with LV tachycardia. The study says tachycardia was solved through surgical procedures as in the Reference papers (4-12) especially as old as Ref.[7].[1993] and Rer.[9]1981.	
	4) The study finds out that probale reason for aneurisym might be <i>hear attack</i> and <i>tachycaria</i> . As a suggestion an elaborate work can be done on finding the reason and link between <i>heart'sstructure</i> and the <i>electrical pulse generation</i> in the heart.
